- (1) Adjudging and declaring that Defendant, Doug Ruccione, violated <u>N.J.S.A.</u> 40:69A-25.1 by improperly and unlawfully rejecting Plaintiffs' Direct Petition;
- (2) Issuing an Order in Lieu of Prerogative Writ directing Defendants to certify Plaintiffs' Direct Petition as sufficient and place it on the November 2, 2021 ballot; and

(3) Adjudging and declaring that Defendant Ruccione's rejection of Plaintiffs' Direct Petition constituted a violation of Plaintiffs' right to substantive due process as well as its statutory right of initiative, in violation of N.J.S.A. 10:6-2(c).
